4. First Aid Measures

<i>Extinguishing media:</i>	Water spray or fog. Alcohol resistant foam. Dry chemical powder. BCF (where regulations permit). Carbon dioxide
<i>Special firefighting procedures:</i>	Alert Emergency Responders and tell them location and nature of hazard. Wear breathing apparatus plus protective gloves. <i>Engineering controls</i>	<p>Local exhaust ventilation is required where solids are handled as powders or crystals; even when particulates are relatively large, a certain proportion will be powdered by mutual friction.</p> <p>Exhaust ventilation should be designed to prevent accumulation and re-circulation of particulates in the workplace.</p> <p>If in spite of local exhaust an adverse concentration of the substance in air could occur, respiratory protection should be considered.
